Application Fee is GYD \$1,000. (Non-Refundable)

<u>Loan Payment Options</u>: SLA Salary Deduction Authorization is <u>MANDATORY</u> (if employed by a Government Entity <u>OR</u> an Established Private Entity that can facilitate), EFT (Electronic Funds Transfer) at any Commercial Bank, Merchant Payments: (MMG, SUREPAY, BILL EXPRESS) USI or Registration # required to do SLA transaction.

ALL GUARANTOR DOCUMENTS:

Guarantor's Affidavit Form – <u>Attested by a Commissioner of Oaths to Affidavits</u>

Revenue Stamps equivalent to the requested **T**uition **C**ost on Registration Invoice -\$1 stamp per \$1000 value.

*Revenue Stamps can be purchased from any of the Guyana Post Offices in the highest denomination. Once purchased, it is required to be affixed to the SECTION F area of the 'Guarantor's Affidavit Form'
